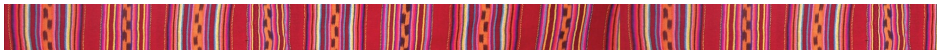
INTRODUSAUN IPK SERI 3

- Presu sa’e signifikante iha grupu Hahan no Bebidas La’os Alkoholika (+0.3%), Komunikasaun (+0.4%) no Transporte (+0.1%). Grupu Ekipamentu no Manutensaun Mobiliariu Uma Laran (-0.4%), Hatais no Sapatu (-0.3%) no Alkohol no Tabako (-0.1%) sai hanesan mudansa kontrariu ba inflasaun grupu hotu.
- IPK Tradeable anual sa’e +0.2%, no IPK Non-Tradable sa’e +1.0%.

Inflasaun Presu Konsumedor hanesan sasukat ida ba nivel presu ba produto no servisu sira nebe kompra no konsume husi uma kain, ne’ebe bele mos sa’e ou tun. inflasaun Presu Konsumedor sukat uza indise presu konsumedor. Komprensaun ba indise presu konsumedor maka presu ba produto no servisu nebe ita determi-na sai hanesan ita nia raga kompra nebe uma kain konsume maioria, indise presu sukat mudansa kustu ou presu ba raga kompra ida ne’e.

Indise presu bele utiliza ba sukat inflasaun. En-jeral liu maka hare ba mudansa indise presu kada tinan nebe halo komparaun entre fulan ida agora (fulan A tinan agora) ba fulan nebe hanesan iha tinan kotuk (fulan A tinan kotuk). Ida ne’e bolu hanesan nivel inflasaun 12-fulan (tinan). IPK anual sa’e (+0.5%) iha tinan ida ne’e ho kalendariu fulan Junho 2026. Kontributor bo’ot liu ba presu sa’e ida ne’e hetan kontribuisaun husi grupu Hahan no Bebidas La’os Alkoholika (+0.8%), ne’ebe afeta husi sub-grupu Modo Tahan (+3.2%), Be, Bebidas, Jus Ai-fuan no Modo Tahan (+10.1%), Mina no Bokur (+5.8%), Ikan no Hahan Tasi (+0.2%), Kafe, Xa, no Kokoa (+0.9%), Ai-fuan (+1.5%) no Paun no Sereal (+2.8%). Sub-grupu Foos (-1.4%), Masin Midar, Marmelada, Banibeen, Cokolate no Hahan Midar (-3.3%), Produto Ai-han (-0.2%), no Susubeen, Keiju no Manutolun (-1.1%) sai hanesan mudansa kontrariu ba inflasaun grupu Hahan no Bebidas La’os Alkoholika.

Grupus Transporte (+7.0%), Edukasaun (+0.3%), Uma (+0.5%) no Komunikasaun (+0.1%). Grupus Alkohol no Tabako (-2.8%), Ekipamentu no Manutensaun Mobiliariu Uma Laran (-1.6%), Rekreaun no Kultura (-0.6%) no Hatais no Sapatu (-0.2%) sai hanesan mudansa kontrariu ba inflasaun grupu hotu anual.

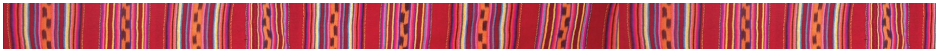
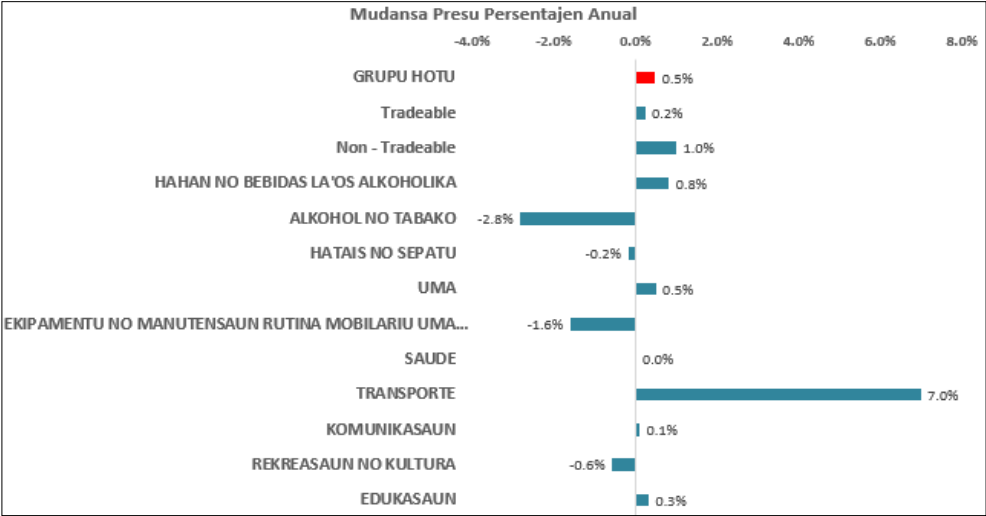


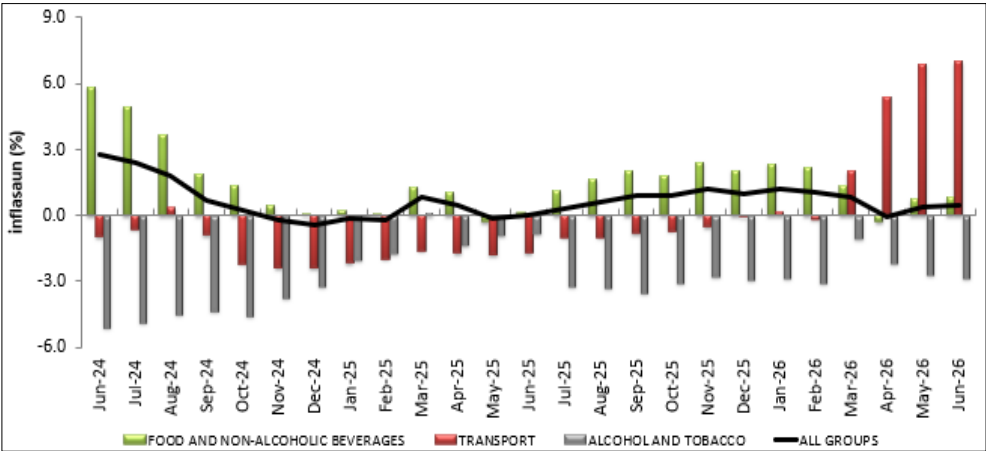
Figura A: Kontribuisaun ba nivel IPK anual, Junho 2026

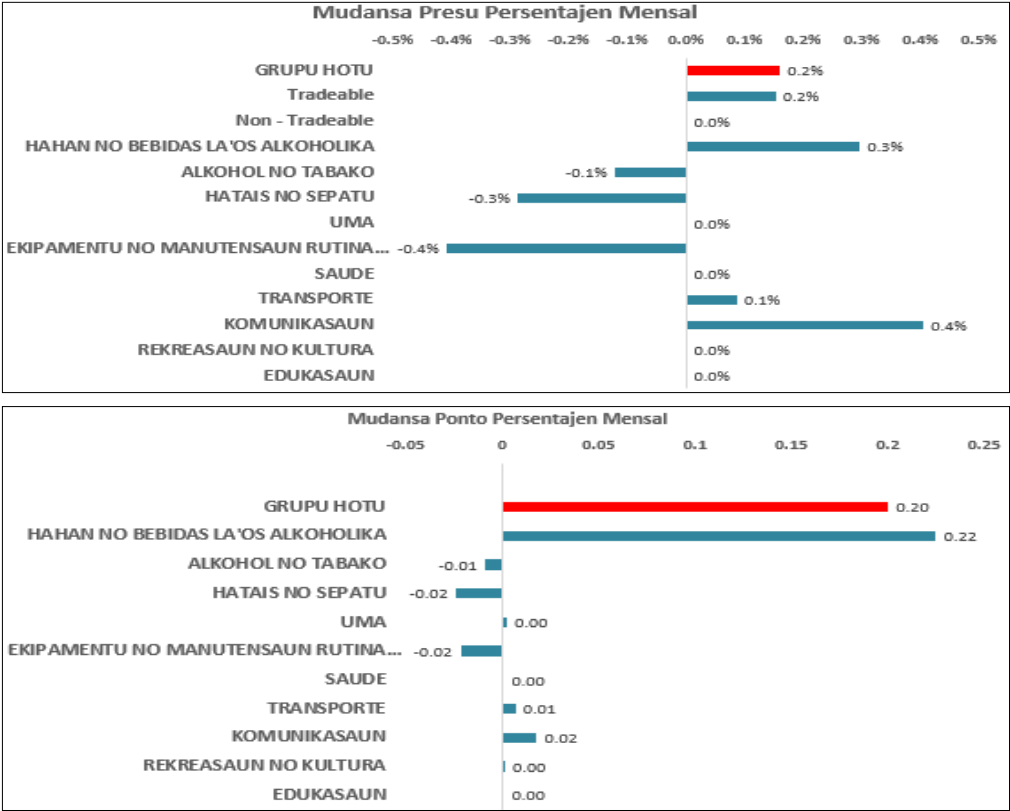

Kontribuisaun importante ba nivel IPK mensal sa'e (+0.2%) entre Junho 2026 no Maio 2026, mai husi:

- **Hahan no Bebidas laos Alkoholika (+0.3%):** afeita husi sub grupu Mina no Bokur (+2.5%), Modo Tahan (+0.5%), Foos (+0.2%), Masin Midar, Marmelada, Banibeen, Cokolate no Hahan Midar (+0.3%) no Ai-fuan (+0.6%). Sub grupu Kafe, Xa no Kokoa (-2.0%), Susubeen, Keiju no Manutolun (-1.0%), no Naan (-0.1%) sai hanesan mudansa kontrariu ba inflasaun grupu hahan no bebidas la'os alkoholika.
 - **Komunikasaun (+0.4%):** Afeita mai husi sub grupu Ekipamentu no Servisu Telekomunikasaun (+0.4%).
 - **Transporte (+0.1%):** Afeita husi sub grupu Operasaun ba Ekipamentu Transporte Pesoal (+0.1%).
- Iha parte seluk, inflasaun grupu hahan no Bebidas la'os alkoholika hetan mudansa kontrariu husi:
- **Ekipamentu no Manutensaun Mobiliariu Uma Laran (-0.4%):** Afeita husi sub grupu Manutensaun ka Hadia uma laran (-1.0%) no Produtu no servisu ba rutina uma laran (-0.3%).
 - **Hatais no Sapatu (-0.3%):** Afeita mai husi sub grupu Asesoris ba Roup a no Sapatu (-1.2%).
 - **Alkohol no Tabako (-0.1%):** Afeita mai husi sub grupu Alkohol (-0.6%).

Figura C: Kontribuisaun ba mudansa nivel IPK mensal, Junho 2026 – Maio 2026



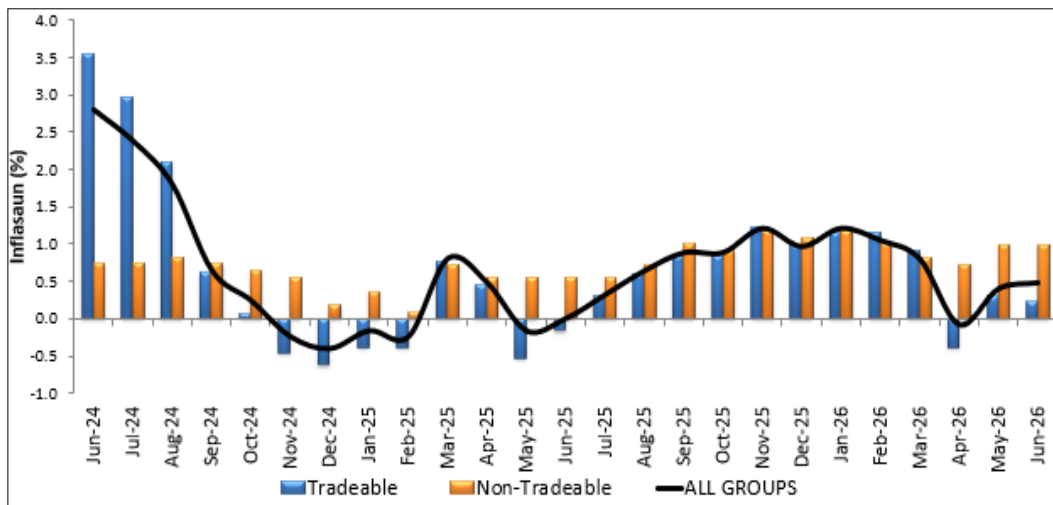

IPK Tradeable no Non-Tradeable

IPK Tradeable no Non-Tradeable, sukat kontribuisaun husi inflasaun domestika (non-tradeable) no importa (tradeable) ba inflasaun en-jeral. Identifikasaun fonte fator inflasaun umakain (konsumedor) ida ne'e suporta atu komprende fator diferente ne'ebe fo impaktu ba inflasaun, nune'e mos ajuda desizaun politika moneter no fiskal.

Definisaun produto no servisu tradeable maka hanesan ida ne'ebe dependensia ba nivel kompetisuan merkadu internasional, no presu produto no servisu sira ne'e hetan influensia husi kompetisaun refere. Hanesan mos, produto no servisu non-tradeable ne'ebe iha depedensia ki'ik liu ba kompetisaun merkadu internasional, no presu produto no servisu sira ne'e konsidera la hetan impaktu direta husi kompetisaun refere. Inflasaun ba produto no servisu non-tradeable reprezenta nivel situasaun ne'ebe nesesidade barak liu (ou ki'ik liu) duke forneshimentu iha ekonomia domestiku. Produto no servisu tradeable sai hanesan depedensia maka'as liu ba kompetisaun internaional, ne'ebe inklui hanesan produto importa televisaun no komputador nomos produto hahan sira seluk. Presu produto sira ne'e hetan influensia presu bot liu husi presu internasional iha merkadu mundial no fluktuasaun valor osan, duke husi fator ekonomia domestiku.
