Introduction

With the publication of this annual External Trade Statistics report, the National Institute of Statistics Timor-Leste provides the latest available data on imports and exports for Timor-Leste during the 2025 calendar year. As a stand-alone indicator, trade statistics form a valuable source of information on the economic health of a country and are widely used by various planning and business organizations.

Statistics on imports and exports are also an important component of a country's economic accounts, including the National Accounts and the Balance of Payments. Accordingly, internationally comparable trade statistics that are accurate, detailed, and timely have always been a statistical priority. Such information is vitally important for the planning and future development of Timor-Leste.

The information contained in this report aggregates the regular monthly releases of trade statistics issued by the Directorate during 2024. Additionally, the report includes tables designed to provide a more comprehensive picture of trading partners than can be obtained from viewing a single month's data. As the Trade Statistics database continues to expand, it is now possible to present comparative annual data.

The statistical methods and concepts used to compile the data for this report closely follow the recommendations of the United Nations publication International Merchandise Trade Statistics: Concepts and Definitions (IMTS), Rev.2, wherever possible.

The objective of the External Trade Statistics 2025 report is to provide an aggregated view of import and export statistics for the 2025 calendar year, while recognizing that more detailed analysis of specific commodities is available upon request from the Institute.

Concepts, definition and explanation of data

The following section aims to provide additional information on the methods used to collect and analyse the trade statistics contained in this report. As already mentioned, these statistics are compiled using the UN “International Merchandise Trade Statistics: Concepts and Definitions (IMTS, Rev.2)” as a guide and quotations from that publication are included here.

Source of Data	Data is obtained from imports and export documents lodged with the Customs Service of Timor-Leste. This data is then processed by the National Institute of Statistics Timor-Leste to produce external Trade Statistics that conform to United national Statistics Concept The ASYCUDA (Automated System for Customs Data) system became operational in the Timor-Leste Customs Service in October 2013. This system provides the basic data from which external trade statistics are prepared. Currently this system provides coverage of all imports and exports. Currently this system provides coverage of all imports and exports from the main airport and is also processed at the Dili customs office, however it should be noted that approximately 4 % of entries (those not lodged electronically via ASUCUDA), are not included in the Trade Statistics.
Time of recording	Imports and Exports Statistics are compiled by Date of Assessment. This is the date on which the duty to be paid (if any) is assessed by the Customs Services, in effect “clearing” the goods for import/export.
System of recording	External Trade Statistics are compiled in close accordance with the United National International Merchandise Trade Statistics Concepts and Definitions. The System is known as the general system of recording trade statistics as defined in UN statistics M52. Under this system, imports include all goods entering the economic territory of a compiling country and exports include all goods leaving the economic territory of a compiling country. The economic territory includes bonded warehouses.
Merchandise Trade	Merchandise Trade is the import or export of goods that after the nation’s stock of material resources as a result of their movement in or out of the country.
BEC (Broad Economic Categories)	The original Classification by Broad Economic categories (BEC) was produced in 1961 to provide a means for international trade statistics to be analysed by Broad Economic Categories such as foods, industrial supplies, capital equipment, consumer durables and consumer non-durables. The original BEC was linked to the standard international Trade Classification .

Non-merchandise Import	Goods that do not permanently add to the material resources of a country are identified as “non-merchandise” trade. Some common examples include temporary imports, returnable containers, goods in transit, and goods consigned to foreign embassies within the host country.
Country Statistics	Import statistics are compiled by country of origin, which refers to the country where the goods were manufactured or produced. Export statistics are compiled by country of destination, which refers to the final country of destination as indicated on the export declaration.
Commodity Classification	Goods are classified by the Customs Service using the national Customs tariff, which is based on the international Harmonized Commodity Description and Coding System (HS) .
Limitation of Data	External trade statistics are compiled from documents provided by exporters and importers to the Timor-Leste Customs Service. Considerable reliance is placed on exporters, importers, and their agents to submit accurate codes and information. Before the data are released for statistical purposes, they are validated and any detected errors are corrected. However, no warranty can be given that the information is completely free from errors. It should also be noted that goods crossing international borders without the appropriate Customs documentation are not included in the trade statistics.
FOB (Free On Board)	Method of Valuation for Export values are recorded on a Free on Board (FOB) basis. This valuation includes the cost of the goods plus the expenses incurred in delivering the goods on board the ship or other means of transport at the port of export, ready for departure.
CIF (Cost Insurance and Freight)	Method of Valuation for values are recorded on a Cost, Insurance and Freight (CIF) basis. This valuation includes the cost of the goods, the cost of insurance during transportation, and the cost of freight to the port of import.
Re-Export	Re-exports are goods leaving the country that were previously imported into Timor-Leste and contain less than 50 percent Timor-Leste value-added at the time of export.

Trade Analysis- Timor-Leste (2021-2025)

Merchandise Import

Timor-Leste import as wide variety of goods, including food, fuel, machinery, vehicles, and construction materials. Due to its limited domestic production capacity, the country depends heavily on import to meet consumption and development needs.

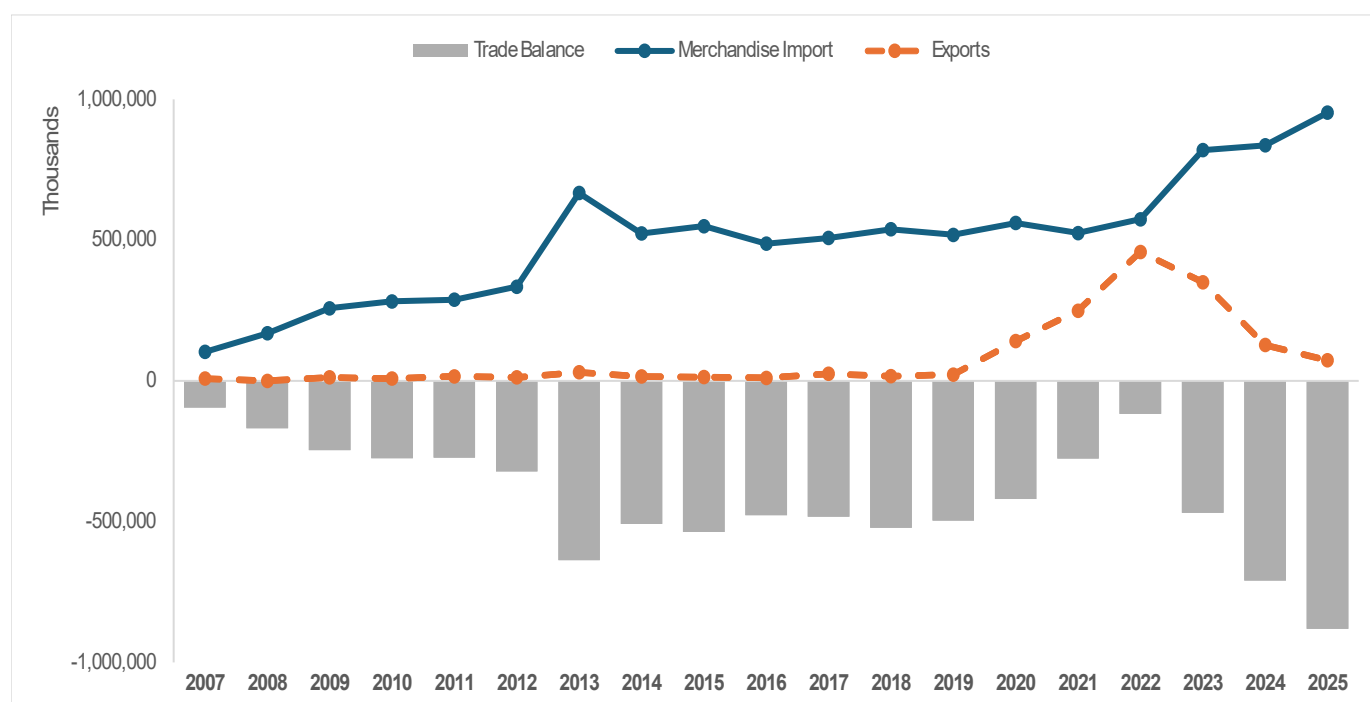
In 2025, merchandise imports amounted to 984,893 million, making a 3 % increase from 2024. This growth was driven by 19 % rise in capital goods and 29 % surge in consumption goods. Highlighting continued demand for imported products to infrastructure, economic activities and household needs

Exports

Timor-Leste Primary export are oil and natural gas extracted from offshore fields in the Timor sea. These commodities dominate the country's export sector, making Timor-Leste highly dependent on global energy prices. In 2025, total exports reached \$99 million, increase from \$73 million in 2024 representing a growth of about 36%.

This increase in export earnings was largely driven by oil export. Meanwhile, coffee export rose significantly from \$17 million in 2024 to \$35 million in 2025, an increase of approximately 106%. This growth was supported by higher international coffee prices and increased export volume. Despite this positive development, the overall export performance continues to reflect the country's vulnerability to fluctuation in the energy sector.

Trade Balance Trends



Key Insight

1. Timor-Leste runs a trade deficit due to high import of machinery and fuel .
2. The economy is heavily reliant on oil export, making it vulnerable to oil price fluctuations.
3. Diversification into agriculture and tourism could reduce this reliance.

Trade Balance

The trade deficit widened to \$885 million in 2025, reflecting the country's continued dependence on imports and relatively low export earnings in Timor-Leste.

Exports refer to goods that contain at least 50 percent Timor-Leste content by value. Re-exports refer to goods that were previously imported into Timor-Leste and contain less than 50 percent Timor-Leste content by value at the time of export. The main re-exported goods are heavy equipment. Individual values may not sum to totals due to rounding.

This impacts farmers' incomes and reduces the competitiveness of Timor-Leste's coffee industry in the global market .

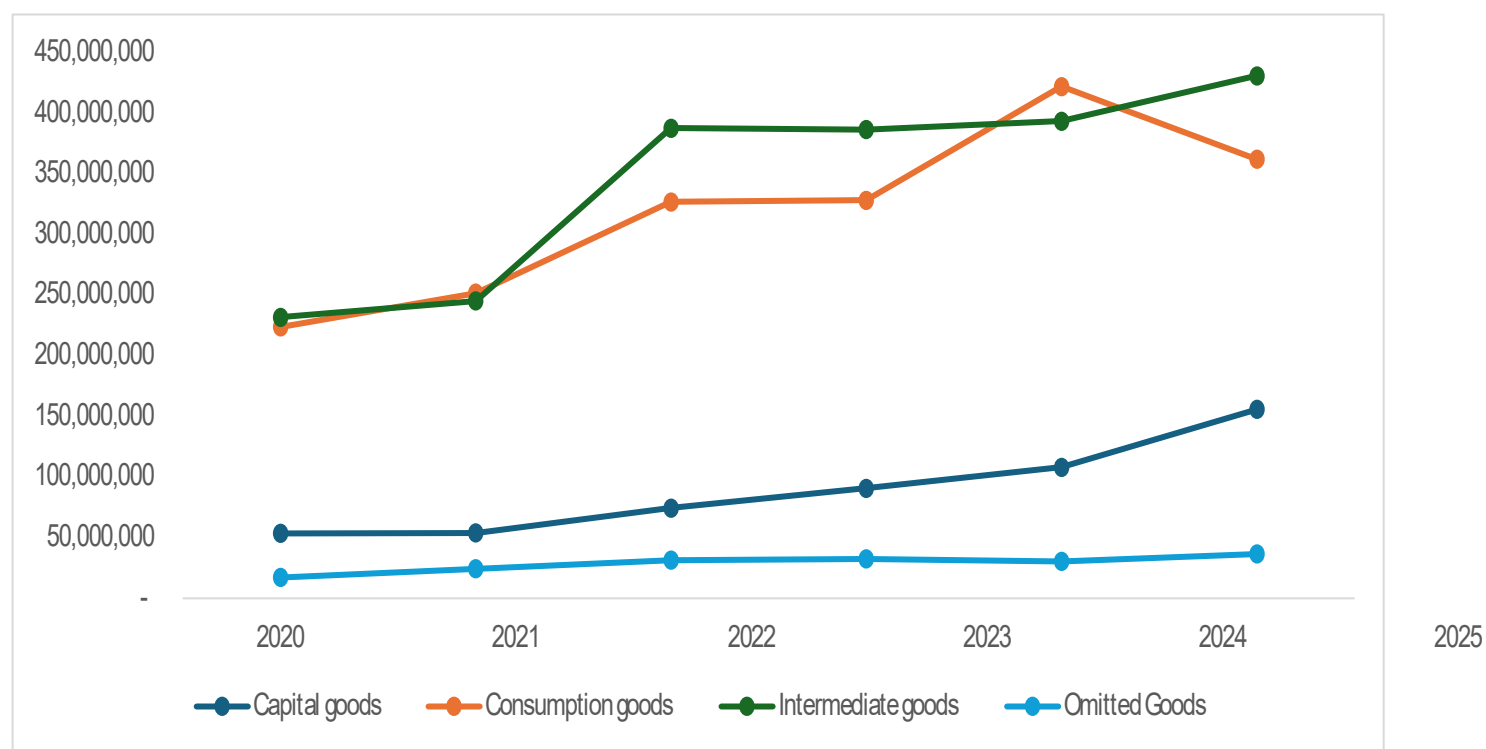
